# Grants & Fellowships

## 1 European Union

### 1.1 Horizon 2020

[Horizon 2020](#) is the EU funding **programme** for research and innovation running from 2014 to 2020 with a €80 billion budget. H2020 supports [SMEs](#) with a new **instrument** that runs throughout various funded research and innovation fields, enhances EU [international research](#) and Third Country participation, attaches high importance to integrate [social sciences and humanities](#) encourages to develop a [gender dimension](#) in project.

**Horizon 2020** offers a large variety of funding opportunities for [research and innovation activities](#) through calls for proposals that are set out in the Horizon 2020 work programme. Access all open calls on the [Horizon 2020 Participant Portal](#).

The European Commission published an overview of **international cooperation opportunities in the H2020 work programme 2016-2017**, including a list of calls targeting Brazil. The list can be found [here](#).

The Brazilian National Council of State Funding Agencies (CONFAP) listed [potential calls of interest for EU-Brazil cooperation](#) in order to encourage the participation of Brazilian researchers under Horizon 2020 calls. Some of them are currently open in diverse areas.

Several FAPs ([FAPESP](#), [FAPESC](#), [FAPEG](#), [FAPEMIG](#), [FAPDF](#), [FAPES](#), [Fundação Araucária](#), [FUNDECT](#)) expressed interest in funding researchers from their states to support their participation in H2020 calls and published [guidelines](#) with instructions to this end.

### 1.2 [ERC Starting Grants](#): Forthcoming call!

European Research Centre (ERC) Starting Grants are designed to support excellent Principal Investigators at the career stage at which they are **starting their own independent research team or programme in all scientific fields**.

The call is due on **3 August 2017**. Expected Deadline: **17 October 2017**

#### ERC Starting Grants in brief:

- For researchers of **any nationality** with **2-7 years of experience** since completion of PhD (or equivalent degree) and scientific track record showing great promise
- An excellent research proposal
- **Research must be conducted in a public or private research organisation** located in one of the EU [Member States](#) or [Associated Countries](#) (including Switzerland)
- Funding per grant: **up to € 1.5 million** (in some circumstances up to € 2 million). An additional € 0.5 million can be made available to cover eligible “start-up” costs for researchers moving from a third country to the EU or an associated country and/or the purchase of major equipment and/or access to large facilities.
- Duration: **up to 5 years**
- Sole evaluation criterion: scientific excellence of researcher and research proposal
- Calls for proposals: published once a year

### **About ERC:**

Set up in 2007 by the EU, the [European Research Council](#) is the first pan-European funding organization for frontier research. It aims to stimulate scientific excellence in Europe by encouraging competition for funding between the very best, creative researchers of any nationality and age. The ERC also strives to attract top researchers from anywhere in the world to come to Europe. It funds young, early-career top researchers (['ERC Starting grants'](#)), already independent excellent scientists (['ERC Consolidator Grants'](#)), and senior research leaders (['ERC Advanced Grants'](#)).

Please, note that ERC grants support projects carried out by an individual researcher ('Principal Investigator') who can **employ researchers of any nationality as team members**. It is also possible to have one or more team members located in a non-European country.

### **1.3 MSCA Co-Funding of regional, national and international programmes (COFUND) call**

Aims to stimulate regional, national or international programmes to foster excellence in researchers' training, mobility and career development, spreading the best practices of Marie Skłodowska-Curie actions.

The COFUND call is open to European research (funding) institutions, Brazilian organisations can be partner organisations in a proposal. COFUND supports many high-quality fellowships or doctoral programme positions, which include transnational mobility.

Brazilian researchers can apply directly to COFUND positions advertised on the [EURAXESS job portal](#).

Deadline: **28 September 2017**.

### **1.4 MSCA PhDs positions in applied superconductivity : the EASITrain Innovative Training Network**

EASITrain is an Innovative Training Network under the Marie Skłodowska-Curie Actions (MSCA) , bringing together industry, universities, laboratories and test-facilities in order to innovate and train **young scientists and engineers** in all aspects related to **applied superconductivity**.

EASITrain is a 4-year project providing a training network for the career development of **15 Early Stage Researchers** (ESRs) on superconducting wires, superconducting thin films, related manufacturing and processing techniques and innovative cryogenic refrigeration. Each ESR is funded by the project for **36 months** and will be enrolled in a **doctorate programme**. The project starts on 1 October 2017.

Deadline: **2 October 2017**

## 1.5 Fellowships for research stays at the European University Institute (EUI)

### 1.5.1 [Jean Monnet Postdoctoral Fellowships](#)



The Robert Schuman Centre for Advanced Studies (RSCAS) offers one or two-year fellowships to postdocs of all nationalities who have obtained their doctorate more than 5 years prior to the start of the fellowship, i.e. 1 September 2017 for the academic year 2017/18. The Fellowship programme is open to post-docs, tenure track academics and those wishing to spend their sabbatical at the Robert Schuman Centre.

The three main research themes of the RSCAS are:

- Integration, Governance and Democracy;
- Regulating Markets and Governing Money;
- 21st Century World Politics and Europe

Deadline: **25 October 2017**

### 1.5.2 [Fernand Braudel Incoming Senior Fellowships](#)

Fellowships last for **up to ten months** in one of the EUI's four Departments which in turn invite fellows to participate in departmental activities (seminars, workshops, colloquia, etc.).

Fellows are encouraged to make contact with researchers sharing their academic interests, may be involved in the teaching and thesis supervision tasks of EUI professors, and associated with one of the research projects being carried out at the EUI.

Next deadline : **30 September**.

## 1.6 [Human Frontier Science Programme \(HFSP\) Postdoctoral fellowships](#)

HFSP postdoctoral fellowships encourage early career scientists to broaden their research skills by moving into **new areas** of study while working in a **new country**. Two possibilities:

- **Long-Term Fellowships (LTF)** are for applicants with a Ph.D. in a **biological discipline**, who will broaden their expertise by proposing a project in the life sciences which is significantly different from their previous Ph.D. or postdoctoral work.
- **Cross-Disciplinary Fellowships (CDF)** are for applicants with a Ph.D. from outside the life sciences (e.g. in physics, chemistry, mathematics, engineering or computer sciences), who have had limited exposure to biology during their previous training.

HFSP fellowships are for **three years**. Fellows may choose to stay for up to three years in the host country or use the last year of their fellowship to return to their home country or to move to another HFSP member country.

Deadline : initiation deadline: **10 August 2017**; Submission deadline **24 August 2017**



HFSP fellowships are open to candidates of all nationalities. Those who are not nationals from one of the supporting countries may apply to work only in a research institution in one of the supporting countries.

## 1.7 EU – [IIASA Postdoctoral Research programme](#)

Every year the International Institute of Applied Systems Analysis (IIASA) located in Laxenburg, Austria, provides full funding **for several postdoctoral researchers of all nationalities.**

The Postdoctoral Program at IIASA offers fully funded research positions of up to **two years** to study topics related to the IIASA research agenda.

Scholars are expected to conduct their own research in collaboration with one or more of IIASA's [research programs or special projects](#).

WHO? Researchers in **natural and social sciences, mathematics, engineering, management and decision sciences** who have their **PhD** at the time of taking up the appointment and are expected to have a proven record of research accomplishments, and a solid working knowledge of English.

Applications are accepted continually, review and selection take place twice a year.

Next deadline: **1 October 2017**

## 1.8 [European Southern Observatory \(ESO\) fellowships and studentships](#)

The European Organisation for Astronomical Research in the Southern Hemisphere - European Southern Observatory (GERMANY, CHILE) offers the following opportunities:

- [Postdoctoral Fellowships](#) offer outstanding early-career scientists the opportunity to further develop their independent research programmes in an exciting scientific environment with close contact to the activities and staff at ESO. Duration: 3-4 years

Deadline: **15 October 2017**.

- [ESO Studentship Programme](#) :These positions are open to students enrolled in a university Ph.D. programme, preferentially but not necessarily in an ESO member state in astronomy or related fields..

Students accepted into the programme work on their doctoral project under the formal supervision of their home university, but they come to ESO to work and study under the co-supervision of an ESO staff astronomer, normally for a period of between one and two years. Studentships may be hosted either at ESO's Headquarters in Garching (Germany) or at ESO's offices in Santiago (Chile), where up to two positions per year are provided for students enrolled in South American universities.

Deadlines: **15 November 2017**; 31 May 2018

## 2.2 BELGIUM (Wallonie-Bruxelles) – [FNRS incoming calls](#)

### 2.2.1 [Fund for research training in industry and agriculture FRIA grant](#)

Support for the completion of the Ph.D. within 4 years. in a university of the French-speaking Community of Belgium in industry and agriculture

Eligible applicants are holders of a master degree (obtained maximum 7 years ago) in one or many fields below: Art of Building and Urban Planning, Medical Sciences, Public Health Sciences (except for Human and Social Sciences disciplines and the likes), Veterinary Sciences, Dental Sciences, Biomedical and Pharmaceutical Sciences, Motricity Sciences, Sciences, except for Tourism Studies and Management and Geographic Sciences (Human or Social Sciences disciplines and the likes), Agronomic Sciences and Biological Engineering, Technology and Engineering Sciences.

Deadline: **29 August 2017**.

### 2.2.2 [Human Sciences Research Fund FRESH grants](#)

The FRESH Fund supports basic research projects whose outcomes are likely to improve the understanding or functioning of one sector in the society in the short-medium term at a local, regional, national or international level, from many perspectives such as economy, politics, culture etc. The granting of FRESH grants is intended for the completion of the Ph.D. within 4 years in a university of the French-speaking Community of Belgium under the supervision of a promoter permanently appointed or on probation

Eligible applicants are holders of a master degree (obtained maximum 7 years ago) in one or many of the following fields: Philosophy, Theology, Language and Literature, and Translation Studies History, Art History and Archaeology, Art of Building and Urban Planning, Information and communication, Political and social Sciences, Juridical Sciences, Criminology, Economical and management Sciences, Psychology and Educational Sciences, Arts and Sciences, Tourism Studies and Management, Public Health Sciences, Geographic Sciences, Environmental Sciences and Management.

Deadline: **29 August 2017**.



FRESH grants are strictly restricted to graduates with an academic education who aim to carry out fundamental research projects with significant societal impact, using tools provided by human and social sciences.



## 2.3 DENMARK – [Industrial PhD and post doc Programmes \(Incoming\)](#)

The **Industrial PhD programme** is funded by the Innovation Fund Denmark. An industrial PhD project is a **three-year industrially focused PhD** project where the student is hired by a company and enrolled at a university at the same time. The company receives a monthly wage subsidy while the university has its expenses for supervising covered. The PhD student works full time on the project and divides his/her time equally between the company and the university.

Innovation Fund Denmark invests in research projects within **all research fields**, provided the research project is of a high quality and is commercially relevant to the company.

Candidates of **any nationality**, holding or expecting to hold soon a **master's** degree with excellent records may apply.

Deadlines for reg. Industrial Postdoc and reg. Industrial PhD: **25 September 2017**; Public sector Industrial Researcher projects: **9 October 2017**

## 2.4 FRANCE (Ifremer) – [Call for candidates for the 2017-2018 post-doctoral grants \(Incoming\)](#)

Ifremer offers post-doctoral positions to young French or **foreign scientists** who have **completed their PhD** and are motivated by development and innovation in various fields of Marine Sciences : technology and ecotechnology, aquaculture, fisheries, environment, risks analysis, physics of oceans, etc.

Postdoctoral positions are contracted for a duration of **12 months**, possibly renewable for a non-renewable 6-month period.

Deadline: **9 September 2017**.

## 2.5 FRANCE – [PRESTIGE Postdoc programme \(Incoming and outgoing\)](#)

The PRESTIGE programme, coordinated by **Campus France**, aims at fostering the international mobility of post-doc researchers.

Three mobility schemes are available:

- **Incoming**, allowing foreign researchers to carry out their post-doctoral research work in France;
- **Outgoing**, for researchers from France wishing to carry out a post-doctoral research project in another country;
- **Re-integration**, targeted at nationals of EU Member States or Associated Countries working in research for at least 3 years in another Third Country to come to France to further develop their career.

PRESTIGE is a co-financing programme, funding about 1/3 of the post-doc fellow's living, mobility and research allowance, while the remaining 2/3 are financed by another partner, either public or private.

WHO? Any post-doc level researcher complying with the Marie Curie Actions mobility rules (not have resided or carried out his/her main activity - work, studies, etc. - in the country of his/her host organisation for more than 12 months in the three years immediately prior to the application deadline) may apply for funding through PRESTIGE programme. Furthermore, each applicant has to secure co-financing for his/her PRESTIGE mobility from the host



The PRESTIGE programme is co-financed under the Marie Curie Actions-COFUND of the FP7.

organisation (for Incoming and Re-integration schemes) or sending organisation (for the Outgoing scheme).

Note that 24-month PRESTIGE co-financing grants under the Incoming and Re-integration mobility schemes may only be awarded to successful applications submitted by the 30/9/2017 cut-off date, and intended for postdoctoral fellowships in France (and related work contracts) starting on 01/12/2017 at the very latest. For later contract start dates and for later cut-off dates, co-financing grants for shorter durations, between 12 and 23 months, may be awarded instead. ### 3.3 BRAZIL - FRANCE – [4th GUYAMAZON Call](#)

The French Embassy in Brazil, the Research Institute for Development (IRD), the territorial collectivity of Guyana, CIRAD and the CNRS, together with the Research Support Foundations of the Brazilian states of Amazonas (FAPEAM), Amapá (FAPEMA) and FAPESPA have launched the 4th GUYAMAZON call, with the objective of developing **joint projects coordinated by researchers from French educational, research and innovation institutions, primarily in Guyana, in partnership with Brazilian counterparts**.



The Coimbra Group of Brazilian Universities (CGBU) is composed of 77 Brazilian Higher Education Institutions. The CGBU's mission is to promote academic, scientific and cultural relations between the group and its international partners through programmes, projects and actions of international cooperation, bilaterally and multilaterally.



The scientific themes are related to **sustainable development in Amazonian territories**: Amazonian biodiversity, terrestrial and forest ecosystems, continental and marine aquatic ecosystems, climate, environment and health, renewable energy, family farming, human and social sciences, heritage and archeology.

The submitted projects should be based on a balanced scientific collaboration between **researchers, lecturer-researchers or engineers** from higher education or research institutions or from companies located in the Northern States of Brazil and in France, preferably within the region of Guyana. Each project must consist of at least 2 teams: one Brazilian team and one French team. Each project must be presented by 2 coordinators: one French and one Brazilian, attached to at least one of the Brazilian states involved. Each part / project team will be funded directly by its country. Project holders may belong to a research institution, a public higher education institution or a private structure (priority SMEs, SMLs and innovative TPEs).

### 3.4 BRAZIL – ISRAEL [4th Joint Call for Proposals for Research and Development \(R&D\) Projects](#) between Brazilian and Israeli Companies

Israel and Brazil announce a Call for proposals for **joint R&D projects between Israeli and Brazilian companies**, aimed at developing innovative products, services, processes or methods in all technology areas and in sectors with strong market potential.

The Israel Innovation Authority will support Israeli companies through access to public funding for joint projects.

Brazilian companies are eligible for financial support from the National Development Bank (hereinafter BNDES), the Brazilian Industrial Research and Innovation Company (hereinafter EMBRAPPII), the State Foundations for Research Support (hereinafter, FAPs) that adhere to the CONFAP Call for Proposals no. 01/2017, and other support institutions.

MDIC and the IIA will provide all necessary assistance to partners for matchmaking and during the project proposal, evaluation and monitoring phases.


#### **Eligible Brazil applicants are:**

- Brazilian companies of any size, registered, based and operating in Brazil.
- Research institutions accredited as EMBRAPPII Units and Poles are eligible to participate and use the resources of EMBRAPPII, observing the required participation of one Brazilian company that will make a partnership with the Israeli side.
- Brazilian research institutions outside the EMBRAPPII System are also eligible to participate, and are eligible for direct support from the FAPs, provided that they are partners with a Brazilian company.
- In the case of BNDES-only support, Brazilian research institutions are eligible only as subcontractors to the applying companies.

#### **Eligible Israel applicants are:**

- R&D performing companies of any size, registered, based and operating in Israel
- Research institutions as subcontractors to eligible companies

Considering the Memorandum of Understanding on bilateral cooperation in research, development and innovation signed by the governments of Brazil and Israel, both countries present the following programme in which each government will provide support to their respective companies involved in joint R&D projects, once approved by both sides.

The program is jointly coordinated by the Secretariat for Innovation and New Business of the Ministry of Industry, Foreign Trade and Services of Brazil (hereinafter MDIC) and the Israel Innovation Authority (hereinafter IIA).

### 3.5 BRAZIL (CONFAP) – UK (Medical Research Council) [Call for Health Systems Research Networks \(MRC\)](#)

Aim : supporting research that aims to improve health policy and systems for vulnerable communities in Brazil.

The UK-Brazil network must include at least two participating Brazilian State Funding Agencies (“FAP”) in Brazil and one UK partner.

Proposed research activities should aim to provide evidence to strengthen the Brazilian health system and improve health outcomes. The joint funders will award proposals for rigorous, high quality research that will:

- Generate evidence on how to strengthen the health system and improve health outcomes in Brazil.
- Inform the delivery of evidence-based interventions or structural changes
- Provide evidence that is of direct relevance to decision makers and users in the field.

Brazilian applicants should refer to CONFAP’s eligibility rules for this call.

Please note it is important to check that the relevant Brazilian State Funding Agency (“FAP”) is participating in this call – not all Brazilian FAPs have agreed to participate. The participants FAPs of this call for proposal are: FACEPE, FAPDF, FAPEAL, FAPEG, FAPEMA, FAPEMIG, FAPEPI, FAPESC, FAPESP, FAPESQ, FAPITEC, FAPT, FUNCAP e FUNDECT.

Some FAPs may have their own Guidelines associated to this Announcement. Interested parties are advised to consult with their supporting FAP before preparing a proposal.

Researchers from the State of São Paulo must consult the FAPESP Guidelines specific for this Announcement.

The proposal must be completed jointly by the applicants in the UK and in Brazil and submitted on the application form.

**Deadline : 26 September 2017**

The joint funders seek interdisciplinary proposals from **UK-Brazil networks** that aim to address **health systems challenges in Brazil**. Proposals must describe how and why the proposed UK-Brazil network would be best placed to develop projects that would have the potential to improve the health of vulnerable communities in Brazil.

### 3.6 Brazil (CONFAP) – UK (Newton Fund) [Newton Advanced Fellowships](#)

This award is available to **international early career group leaders** to develop their research by linking them with some of the best research groups in the UK.

The aim is to:

Support the development of a well-trained research community who can **contribute to poverty alleviation** by transferring new skills and creating new knowledge which can lead to changes in the wellbeing of communities and increased economic benefits.

**Strengthen research excellence in partner countries** by supporting promising independent, early-career scientists and their research groups and networks to develop their research through training, collaboration, **reciprocal visits** and the **transfer of knowledge and skills from the UK**.

Establish **long-term links between the best research groups** (and networks) in partner countries and the UK to ensure that improvements in research capacity are sustainable in the longer term.

#### Eligibility

Applicants must have a **PhD** or equivalent research experience and hold a permanent or fixed-term contract in an eligible university or research institute, which must span the duration of the project. Applicants should have no more than 15 years of postdoctoral experience. Collaborations should focus on a single project involving an overseas-based scientist (“the Applicant”) and a UK-based scientist (“the Co-applicant”).

In Latin America, awards are currently only available for scientists in the following countries:

- **Brazil (in partnership with [CONFAP](#))**
- **Mexico (in partnership with the Mexican Academy of Sciences ([MAS](#)) and the National Council of Science and Technology ([CONACYT](#)))**

Duration: Awards last for up to **three years**.

Funding: Up to £37,000 is available each year
