Established by the European Commission

European Research Council (ERC) funding schemes are open to top researchers of any nationality or age who wish to carry out their frontier research in the 28 EU Member States or associated countries.

# **Grants & Fellowships**1European Union

#### 1.1 Horizon 2020

<u>Horizon 2020</u> is the EU funding **programme** for research and innovation running from 2014 to 2020 with a €80 billion budget. H2020 supports <u>SMEs</u> with a new **instrument** that runs throughout various funded research and innovation fields, enhances EU <u>international research</u> and Third Country participation, attaches high importance to integrate <u>social sciences and humanities</u> encourages to develop a gender dimension in project.

**Horizon 2020** offers a large variety of funding opportunities for research and innovation activities through calls for proposals that are set out in the Horizon 2020 work programme. Access all open calls on the <a href="Horizon 2020 Participant">Horizon 2020 Participant</a> Portal.

The European Commission published an overview of **international cooperation opportunities in the H2020 work programme 2016-2017**, including a list of calls targeting Brazil. The list can be found here.

The Brazilian National Council of State Funding Agencies (CONFAP) listed potential calls of interest for EU-Brazil cooperation in order to encourage the participation of Brazilian researchers under Horizon 2020 calls. Some of them are currently open in diverse areas.

Several FAPs (<u>FAPESP</u>, <u>FAPESC</u>, <u>FAPEG</u>, <u>FAPEMIG</u>, <u>FAPDF</u>, <u>FAPES</u>, <u>Fundação Araucária</u>, <u>FUNDECT</u>) expressed interest in funding researchers from their states to support their participation in H2020 calls and published guidelines with instructions to this end.

#### 1.2 ERC Advanced Grants: Call open!

ERC Advanced Grants are designed to support excellent Principal Investigators at the career stage at which they are already established research leaders with a recognised track record of research achievements. This action is **open to researchers of any nationality** who intend to conduct their research activity in any European Member State or Associated Country.

The ERC's frontier research grants operate on a 'bottom-up' basis without predetermined priorities. The call 'ERC-2017-ADG' consists of **one call with a single deadline** applying to each of the three main research domains:

- Physical Sciences & Engineering
- Life Sciences
- Social Sciences & Humanities

**Eligibility**: any nationality, any age. Applicants must be leaders in their respective field(s) of research and must demonstrate significant achievement in the last 10 years

Location: research must be conducted in a public or private research organisation (known as a Host Institution/HI). It could be the HI where the applicant already works, or any other HI located in one of the EU <a href="Member States">Member States</a> or <a href="Associated Countries">Associated Countries</a>

**Funding**: up to € 2.5 million per grant (up to € 3.5 million in some cases)

Duration: up to 5 years

Sole evaluation criterion: scientific excellence of researcher and research proposal

Deadline: 31 August 2017

#### Important notice: Time to spend on the project

Researchers applying for ERC-funding must be strongly committed to the project and spend a significant amount of time on it. However, it is not obligatory to spend 100% of your time in Europe whilst carrying out the ERC-funded research.

For Advanced Grants, the Principal Investigator should devote at least 30% of her/his working time to the ERC project and spend at least 50% of her/his total working time in a <u>EU Member State</u> or <u>Associated Country</u>.

#### 1.3 CERN fellowship programme (Incoming)

The European Organisation for Nuclear Research (CERN) <u>Fellowship Programme</u> is addressed to graduates from universities or higher technical institutes in a wide range of applied sciences, computing and engineering with limited or no work experience.

Senior Fellowships are awarded to doctorate (PhD or equivalent) graduates whereas Junior Fellowships are intended for BSc or MSc graduates looking to work in a research group.

WHO? national of a CERN <u>Member State</u>. However, a limited number of positions are also available to young scientists from Non-Member States with a Senior profile.

Deadline: 4 September 2017

## 1.4 <u>Fernand Braudel Incoming Senior Fellowships</u> (Incoming)

Fellowships last for **up to ten months** in one of the EUI's four Departments which in turn invite fellows to participate in departmental activities (seminars, workshops, colloquia, etc.).

Fellows are encouraged to make contact with researchers sharing their academic interests, may be involved in the teaching and thesis supervision tasks of EUI professors, and associated with one of the research projects being carried out at the EUI.

Next deadline: 30 September 2017

## 1.5 <u>European Institutes for Advanced Study (EURIAS)</u> <u>Fellowship Programme</u> 2018-2019 (Incoming)

WHAT? Mobility programme offering **10-month residencies** in one of the **19 participating Institutes**: Aarhus, Amsterdam, Berlin, Bologna, Budapest, Cambridge, Delmenhorst, Edinburgh, Freiburg, Helsinki, Jerusalem, Lyon, Madrid, Marseille, Paris, Uppsala, Vienna, Warsaw, Zürich.

EURIAS Fellowships are mainly offered in the fields of the **humanities and social sciences** but may also be granted to scholars in **life and exact sciences**, provided that their proposed research project does not require laboratory facilities and that it interfaces with humanities and social sciences.



The Programme welcomes applications worldwide from promising young scholars (postdoc) as well as from leading senior researchers.



EMBO offers the largest number of life science events in Europe. EMBO Courses & Workshops funds approximately 90 events attracting more than 11,000 participants every year.

WHO? Open to **all nationalities**. **International post-doc** (PhD + 2 to 9 years of full-time research experience) and senior researchers (PhD + minimum 10 years of experience)

For the 2017-2018 academic year, EURIAS offers <u>54 fellowships</u> (26 junior and 28 senior positions). All IAS have agreed on common standards, including the provision of a living allowance (in the range of EUR 26,000 for a junior fellow and EUR 38,000 for a senior fellow), accommodation (or a mobility allowance), a research budget, plus coverage of travel expenses.

Deadline: 7 June 2017

## 1.6 European Respiratory Society (ERS) - Short-Term Research Training Fellowships (Incoming)

The ERS allow young scientists and clinicians to visit a host institution in Europe. Short term stays of 1-3 months are supported.

All nationalities, European and non- European based candidates are allowed to submit a project proposal

Next deadlines: 1 October 2017; 1 April 2018

#### 1.7 EMBO Courses and Workshops

Funding is available to organise conferences, EMBO/EMBL Symposia, workshops, EMBO/FEBS Lecture Courses, Global Exchange Lecture Courses and practical courses, as well as for keynote lectures. <a href="Travel grants">Travel grants</a> support the attendance of participants from countries with less-developed scientific infrastructures. EMBO assists the organizer with the design of a poster, set-up of a website and registration system, and with promotion of the event.

Next deadline: 1 August 2017

#### 1.8 EURAXESS Jobs

There are currently **around 7400 research jobs** (all over Europe, but also in other countries such as in Brazil and in all disciplines) announced on the <u>EURAXESS Jobs database</u>. Opportunities can be viewed by country, level of seniority, field or research or via free text searches.

Please note that these jobs also include **doctoral positions**, including those funded by the Marie Sklodowska Curie Actions (MSCA - ITN) and by the European Research Council (ERC).

## 2 EU Member States and Associated Countries

#### 2.1 National EURAXESS Portals

The latest information on open calls for national grants and fellowships in the 40 member countries of the EURAXESS network can be accessed on the respective **national EURAXESS portals**:

#### 2.2 AUSTRIA - OeAW Doctoral Fellowship Programme

The Austrian Academy of Sciences (OeAW) is offering Doctoral fellowships to enable young, excellent doctoral candidates from **all disciplines and nationalities** to carry out their PhD project within a definable period of time in Austria.

Applicants must have obtained their master's degree less than 2 years prior to the deadline. Upon successful application, they must enrol in a doctoral programme in Austria. The fellowship provides a gross annual sum of EUR 38 000 for a duration of 24 to 36 months.

Deadline: 15 September 2017

## 2.3 BELGIUM - BAILLET LATOUR Health Prize Call for nominations

This personal award is intended to recognize outstanding scientific achievements in **biomedical research** for the benefit of human health and to encourage the laureate in the pursuit of his/her career. The Prize is open to scientists of all nationalities who have not received an equivalent Prize for their personal use.

Exceptionally, the Prize may be shared between two persons who have collaborated over a long period. The laureate will be selected by an international Jury in February 2018.

The themes for the following years will be: **Cancer (2018**), Cardiovascular Diseases (2019), Metabolic Disorders (2020), Infectious Diseases (2021).

Deadline: 30 September 2017

## 2.4 FRANCE - Centre for Integrative Biology of Toulouse New Group Leaders Programme (Incoming)

The Centre for Integrative Biology of Toulouse launched **two international calls** for the recruitment of outstanding group leaders.

In order to reinforce its research endeavors in an inspiring, collaborative and cutting-edge environment, the CBI is seeking new **talented group leaders**, **at junior or midcareer level**, addressing:

## 2.5 GERMANY - <u>Sofja Kovalevskaja Award</u> of the Alexander von Humboldt Foundation (Incoming)

This award aims to supports particularly promising young researchers from abroad. Award-winners receive **up to 1.65 million Euros over a period of five years**, to be spent on any research project they choose. This allows them to establish their own working group at a research institution of their choice in Germany and to cover their own costs of living. The award is funded by the Federal Ministry of Education and Research (BMBF). The Humboldt Foundation plans to grant **up to six Sofja Kovalevskaja Awards**.

WHO? Open to Brazil-based researchers from **all disciplines** who have completed their PhD (or equivalent academic qualification) within the past six years and hold an outstanding academic track record.

Deadline: 31 July 2017



**GSO** Leadership Academy is a joint project of Scholars German Organisation with Fraunhofer Society, Helmholtz Association of German Research Max Centres. Planck Society, and Klaus Tschira Foundation. Associated Partners are the Center for Science Management (ZWM),Association of Technical Universities (TU9), and the German Association University Professors and Lecturers.

## 2.6 GERMANY - GSO Leadership Academy for Scientists and Researchers (Incoming)

Are you a young **German-speaking scientist or researcher** and are about to take the next step in your career? Are you interested in pursuing a career in Germany?

The programme is designed for **25 outstanding researchers of all disciplines and all nationalities** who are about to take the next step in their career – as a junior group leader in science or industry, as assistance or full professor, as founder of a start-up or as someone taking responsibility in a research-related organisation.

In two intensive five day training phases that blend self-assessment, interactive group workshops, case studies, videos, and lectures with individual mentoring and coaching, participants will be able to develop the skills they need for the next big step in their careers. They will gain a better understanding of their personal approach to leadership, experience what it means to model leadership in research-related environments, and learn how they can further push their personal development. As a group they will motivate and surprise each other and forge essential professional bonds with each other and with key players in their field.

Netherlands, Norway, Poland, Portugal, Romania, Slovakia, Slovenia, Spain, Turkey, the United Kingdom, and the United States.

# 2.7 IRELAND – Science Foundation Ireland (SFI) <u>Industry fellowship Programme 2017 (Incoming and outgoing)</u>

WHAT? Programme aiming at **facilitating exchanges between academia and industry** to stimulate excellence through knowledge transfer and training.

Fellowships can be awarded to academic researchers wishing to spend time in industry worldwide and to individuals from industry anywhere in the world (including Ireland) wishing to spend time in an eligible Irish Research Body.

Fellowships can be for between 1 and 12 months in duration if full time or 2 to 24 months if part time. The maximum Industry Fellowship award amount is EUR 100.000 direct costs.

Two deadlines: 6 July 2017; 23 November 2017

#### 2.8 ITALY - EURAC Federal Scholar In Residence

For comparative research at the European Academy of Bolzano/Bozen (EURAC); Aims at weaving experts and their networks in order to develop and advance comparative federal and regional studies.

Ths annual programme welcomes applications from academics, post-docs and practitioners in federalism, regionalism and intergovernmental relations.

Deadline of submission: 1 July 2017

## 2.9 ITALY –<u>Eisenhower Fellowship Programme at NATO Defense College in Rome</u>

The NATO Defense College currently offers three fellowships each year in the field of defense and security policy research related to NATO and its partners. The objective is to promote research and political consulting in areas of particular interest to the Euro-Atlantic Partnership Council (EAPC), to NATO's partners in the Partnership for Peace (PfP) and to NATO's Mediterranean Dialogue (MD) partners and Other Military Cooperation (OMC)/Partners Across the Globe (PAG).

Each Fellow will receive between 10 000 euros – 14 000 Euros to be used for his/her stay in Rome and his/her travel expenses.

Each fellowship will last for four months, during which the fellow will be located at the NATO Defense College, in Rome, Italy.

Deadline: 1 September 2017

#### 2.10 ITALY - CICOPS Scholarships 2017

WHAT? Academics and other reserchers from Developing Countries who wish to carry out research in collaboration with a professor at the **University of Pavia** are welcome to apply. Applicants must have the support of a collaborator at the University of Pavia who invites them with a formal invitation letter (applications without invitation letter won't be taken into consideration).



WHO? Applicants must have at least **two years of either teaching experience or activity in international organisations and institutions**. CICOPS scholarships are foreseen for research collaboration in the **short period** in order to encourage the mobility of researcher from developing countries. Applicants enrolled in a Doctoral or Postgraduate Course at an Italian University are not eligible to apply.

Deadline: 31 May 2017

## 2.11ITALY - <u>The Scuola Universitaria Superiore IUSS</u> Pavia, PhD positions (Incoming)

ELIGIBILITY: Master degree or similar academic qualification obtained abroad by recognised academic institution that gives the admission to the PhD Programme in the foreign country

LANGUAGE: English DURATION: 3 years

PhD course of interest: awarded for the 1st Year and confirmed on a yearly basis for admission to the subsequent year subject to the decision by the Teaching Board of the individual programmes

#### 2.12ITALY – <u>STARS Grants - Supporting Talent in</u> Research, University of Padova (Incoming)

\*STARS Starting Grants\* (STARS-StG) are designed to fund excellent PIs who have been awarded their **first Doctoral degree** within a minimum of 2 and a maximum of 7 years (prior to 1 January 2018) and who are

about to establish their own research team and/or who are starting their own independent research.

DURATION: STARS-StG fund research projects for the duration of two years.

Deadline: 30 June 2017

## 2.13NETHERLANDS (KNAW) - Evert Willem Beth Foundation: funding for research and symposiums

The Royal Netherlands Academy of Arts and Sciences (KNAW) Evert Willem Beth Foundation funds some research and symposiums in the following disciplines: modern logic, philosophy of science, history of logic, history of the philosophy of science and scientific philosophy in general.

Students as well as researchers can apply. Continuous application.



Through the initiative "Supporting TAlent in ReSearch@University Padova" - STARS Grants, the University of Padova intends to promote and encourage high quality, innovative and ambitious research Padova, with the final goal to strengthen the ability to attract external competitive grants, like those awarded by European Research the Council.



#### 2.14NETHERLANDS - The Royal Netherlands Academy of Arts and Sciences (KNAW): <u>Visiting Professors</u> <u>Programme</u> (VPP)

The Visiting Professors Programme enables outstanding foreign researchers to spend time working in the Netherlands. The programme acts as an incentive for Dutch science and scholarship. KNAW members, researchers at KNAW institutes, members of KNAW's De Jonge Akademie (Young Academy) and KNAW Academy Professors can submit nominations for a Visiting Professorship.

Next deadline: 1 November 2017

#### 2.15NORWAY - InternAbroad (Outgoing)

InternAbroad is a pilot initiative that will support Norwegian higher education institutions that aim to establish the structures, routines and networks necessary for providing internship opportunities for **students they send abroad** 

InternAbroad is a pilot initiative developed by SIU and supported by Innovation Norway. The objective is to increase the number of students from Norway who do a credit-yielding internship or work placement abroad, where they get practical experience in a job, enhance intercultural competencies and language skills, and acquaint themselves with work environments and business cultures in a foreign country. As a result, students will benefit from a more relevant education, and companies and organisations will benefit from access to a pool of talented students who may become future employees.

DURATION: Projects may be awarded for a two-year period

FUNDING: up to NOK 300 000 (approx. € 32,000); Funding can be used for development, travel costs, student scholarships and other relevant costs.

In addition to financial support, SIU will offer advice and assistance to the projects that are selected for funding. This includes workshops during the project period for the purposes of developing and sharing best practice related to organising internships abroad. Innovation Norway's offices in the respective markets will share network and help make connections between the relevant parties.

The internships may be undertaken in any form of business or organisation, whether it is small or large, private or public, for-profit or non-profit. Eligible host organisations include, but are not limited to, companies, government departments and agencies, embassies, hospitals, schools, kinder gardens, NGOs and research institutes.



Regular Research Awards, Thematic Projects, Young Investigators, Research, Innovation and Dissemination Centers (CEPIDs/RIDCs), Public Education Research ProgramME, Research in Public Policies, and Research Partnership for Technological Innovation (PITE). Co-Principal Investigators of ongoing Thematic Projects, CEPIDs/RIDCs and PITEs are also eligible to apply.

The call is also open to proposals from researchers whose partners are from institutions with which FAPESP does not have a current agreement. In that case, the principal investigator must present to FAPESP evidence of availability of matching funds.

The Regional Programmes MATH-AmSud and STIC-AmSud are initiatives of the French cooperation and their counterparts from Argentina, Brazil, Chile, Colombia, Ecuador, Paraguay, Peru, Uruguay and Venezuela, aimed to promote and strengthen the collaboration and to create networks of research and development in the field of mathematics (MATH-AmSud) and in the field of Information and Communication Science and Technology (STIC-AmSud), for the realisation of joint projects through the mobility of investigators.

**SPRINT** proposals has the purpose of promoting the engagement of researchers affiliated institutions higher education and research in the State of São Paulo in partnership with researchers abroad in order further develop qualitatively the ongoing research projects and work cooperatively aiming at the elaboration of joint research projects of medium and long term.





- Each project must involve at least one French research group and at least two research groups belonging to two of the South American countries which participate in the programme.

#### **FUNDING**

- The approved funding is subject to the annual budget availability of the different agencies. As a reference, the institutions of the program jointly contribute an annual amount of approximately € 10 000 to € 15 000 per project.
- It is recommended to contact each organisation participating in the programme for orientation on the funding requests from the different counterparts.
- The funding will be delivered annually.
- The financing modalities are the following: the agency that sends pays for the travel costs and the accommodation costs of its own researchers.
- The costs shall be detailed by mentioning the amount of missions, the goal of each mission, the duration, the country of destination, and the name of the beneficiary.
- The budget should indicate the requested funding from:
  - each South American agency that participates in the program.
  - the French Ministry for Foreign Affairs and International Development
  - the French laboratories or institutions participating in the program

#### **DURATION**

Each project should plan its activities considering the maximum duration of **two years**. The release of the results is scheduled for November this year. Up to five projects of each tender can be approved, which will begin in 2018.

- The duration of missions may not exceed 30 days.



How it works:

Higher education institutions interested in receiving a Researcher Connect course will be represented by a candidate, who will be required to register as "coordinator of the course". In the proposal, he / she must choose one of the four course options available, according to the specific interests of his / her institution.

Each institution can host a single edition of Researcher Connect per year. If there is only one enrollment in the State, another campus of the same institution may receive a second edition of the course. Each edition of the course should include at least 20 researchers. The level of English required to participate in the course is B1, according to the <a href="Common European Framework of Reference for Languages">Common European Framework of Reference for Languages</a>.

#### Application Requirements:

The coordinators of the course must be full-time researchers or professors appointed by the Pro-Rectorate of Research, Postgraduate Degrees, department heads or graduate programmes of an educational or research institution, public or private, affiliated to one of the FAPs of the states contemplated.

The course coordinator will be the contact point between the British Council for course type selection, logistical coordination and budget control. He / she will also be responsible for the selection process of the participants and for the final monitoring and evaluation of the course.

The course coordinator will not be an instructor and will not have specific knowledge related to the English language or scientific communication. The instructors and course materials will be provided by the British Council. Proposals from researchers in all areas of knowledge will be accepted provided that the research line brings a social and / or economic benefit to Brazil, that is, to demonstrate direct or indirect impact on vulnerable or low-income populations.

#### **Rural Development and Biodiversity**

The British Council, using the resources of the Newton Fund in Brazil, and the Research Support Foundations of Alagoas (FAPEAL), Federal District (FAPDF), Goiás (FAPEG), Maranhão (FAPEMA), Mato Grosso do Sul (FAPESC), Paraná (Araucária Foundation), Santa Catarina (FAPESC), São Paulo (FAPESP) and Sergipe (FAPITEC) are participating in the global call 2017/2018 of the Institutional Links programme.

OBJECTIVE: Institutional Links, operated by the British Council, accepts proposals for a set of cooperation activities between Brazilian and British institutions including workshops, missions, lectures and other exchange activities that can be carried out for up to two years.

FUNDING: Minimum budget of £ 100,000 and a maximum of £ 140,000.

DURATION: Proposals must last **between 18 and 24 months** and be in line with the eligible topics of the respective states, described in the item Thematic Guidelines here.

Each proposal must have a **Brazilian candidate and another candidate from the United Kingdom**, and be submitted jointly on the British Council's global website. Both institutions, Brazilian and British, must be able to administer the concession.

Institutions selected may include associated (non-profit) partner institutions for the execution of the project. Leading researchers are encouraged to include partner affiliates in other research or higher education institutions and technology transfer offices in their proposals.
